About Equileap

Equileap is an independent, specialized data provider and the leading organization providing data and insights on gender equality in the corporate sector. Equileap's Gender Equality Scorecard™

Equileap assesses 4,000 companies across 23 developed markets on 19 criteria including gender balance at all levels of the company, the gender pay gap, policies relating to paid parental leave and

anti-sexual harassment, and gender audit – which make up Equileap's proprietary Gender Equality Scorecard. For each gender criterion, one or several metrics have been identified to evaluate it. A score and weighting are allocated to each criterion to reflect that some issues may be more important for furthering gender equality than others.

Equileap works with key gender equality and DE&I experts to select the critical metrics for promoting equity in the workplace within the current global environment surrounding gender equality. EDGE Certified Foundation is one of those key stakeholders and this is reflected in the synergies between Equileap's gender metrics and EDGE's proven methodology. There is also a specific question in the Category on Commitment, Transparency and Accountability of the Scorecard which highlights the importance of gender equality certification:

Has your company undertaken and been awarded an independent gender audit certificate by an Equileap recognized body?

EDGE Certification is an Equileap-approved gender audit. As such, this question presents a direct scoring opportunity for EDGE Certified organizations, and one which improves in line with the different certification levels: EDGE Assess, EDGE Move and EDGE Lead.

Demonstrating gender equality leadership

Currently, very few organizations completing the Scorecard are scoring points for independent gender audit certification: in 2021, just over 1% of companies evaluated by Equileap had been awarded a certification. Being EDGE Certified, therefore, can help organizations that want to improve their Equileap score, get ahead of the competition in their country or industry, and improve their visibility to the investment community using a gender lens to inform their investment strategies.

Reducing the burden

EDGE Certification has reached widespread adoption by organizations around the world and in many different industries. These EDGE Certified organizations choose to be independently verified against the highest standard in diversity, equity and inclusion and they use EDGE Certification to make their DE&I progress visible to the outside world. By following EDGE's methodology to become EDGE Certified, these companies also have the necessary information to hand when it comes to ESG reporting. Therefore, being EDGE Certified helps to reduce the overall time and effort spent on reporting, which can be a heavy burden, especially given that organizations face a large number of different ESG ratings and rankings.

In addition to Equileap, EDGE Certified Foundation connects with a number of other data providers and ESG indices, helping to shape and form the backbone of their assessment methodology in DE&I. Being EDGE Certified will continue to support your workplace DE&I progress and ensure this progress contributes positively to the ESG-related data and information that is financially relevant to the investment community.
